### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

### **Additional Terms & Conditions:**

- 1 The Bidder's offer is liable to be rejected if they don't upload any of the required certificates/documents sought in the bid.
- 2 An office of the service provider must be located in the Gujarat state. Documentary evidence must be submitted.
- 3 Bidder must have dedicated /toll free telephone no. for service support
- 4 Bidder/service provider must provide escalation matrix of telephone numbers for service support.
- 5 Service Provider shall first pay Salaries / wages of contracted staff deployed at buyer location i.e. on their own, and then claim payment from Buyer along with all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.
- 6 The buyer/Department reserves the right to increase or decrease the quantity of manpower to be ordered up to 25 percent at the time of placement of contract. The buyer also reserves the right to increase or decrease the ordered quantity by up to 25% of the contracted quantity during the period of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 7 The Bidder should have regularly rendered similar service to any Central / State Govt. Organization / PSU / Public Listed Company for atleast 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having rendered such service during each of the year.
- 8 Duration of the service, the contract may be extended up to 3 months, or as permitted by the GeM platform beyond the initial contract duration (subject to satisfactory performance and mutual consent).

9 The Gym Instructor must have previous work experience for at least 3 years as a Fitness Trainer or similar role and must possess diploma in the field of fitness training or similar field. The Hired Trainer shall have knowledge of diverse exercises and must be available to work on early or late shifts. Further the Hired Trainer shall have experience of CPR and First Aid.

10 The Cook must have previous work experience of at least 3 years in any office with daily cooking requirement for at least 30 persons.

11 In case more than one bidders tie as L1 bidders, the service provider having provided services satisfactorily in Income-tax Department in the past shall be given priority, if GeM platform permits.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

**For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.**

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
