2. The applicants were required to submit applications on or before 31.12.2025. The selection process is a two stage process, involving i) Screening and ii) interview.

3. In this regard, the screening criteria of applications are as follows:-

- a) Incomplete applications have been summarily rejected.
- b) Applications received after due date have been summarily rejected.
- c) Applications with the age of applicant as on date of advertisement exceeding 35 years have been rejected.

d) Applications in which essential educational qualification specified in the advertisement i.e. i) applicant should be an Indian Nationals holding Graduate /Post Graduate degree in Law from recognized Universities, Colleges and Institutions of National and International repute, and/or a Chartered Accountant. ii) Candidates should have obtained at least 50% marks in the 3 year LLB or 5 Year integrated LLB degree program or Post Graduation degree program or a qualified Chartered Accountant, are not fulfilled have been rejected.
