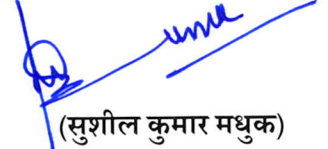
Except for the above correction, all other terms and conditions contained in the original approval order dated 08.07.2026 shall remain unchanged and continue to be in force.

Reference is invited to the Advertisement for Recruitment of Meritorious Sportspersons in the Income Tax Department, Gujarat under Sports Quota Recruitment Year 2025 published on the Department's website <https://www.incometaxgujarat.gov.in> on 31.01.2026.

It is hereby notified that **Para 6 (Selection Criteria)** of the aforesaid advertisement stands modified to the following extent:

Existing Provision

*"All the applications received within the prescribed time will be scrutinized on the basis of eligibility criteria/qualification/instructions laid down in this advertisement as well as on the basis of eligibility fixed by the Sports Recruitment Committee and the candidates will be shortlisted for the available vacancies for recruitment of meritorious sportspersons. **For selection, the shortlisted candidates would be required to appear in a written examination.** Success in the written examination confers no right to appointment unless the Department is satisfied after enquiry, as may be considered necessary, that the candidate is suitable in all respects for appointment to the post."*

Having considered the basic educational qualification and other factors, the above provision relating to the written examination is waived.

Accordingly, **no written examination shall be conducted** for the Sports Quota Recruitment Year 2025.

The selection of candidates shall be made on the basis of scrutiny of applications, evaluation of sports achievements, fulfilment of the prescribed eligibility conditions, the order of preference and other applicable criteria as prescribed in the advertisement dated 31.01.2026.

All other terms and conditions of the advertisement shall remain **unchanged** and shall continue to be applicable.
