CORRIGENDUM

An Order of renewal of approval of Hospital under sub-clause (b) of clause (ii) of the proviso to sub-clause (viii) of clause (2) of section 17 of the Income-tax Act, 1961 was passed in the case of M/s S. Ltd., Hanumangarh-Suratgarh Bypass Road, Sri Ganganagar, [PAN-AAQCS5994N], vide No.2467 of 06.01.2026 and having DIN & Letter No: ITBA/COM/F/17/2025-26/1084481234(1).

There has been a typographical error in the Para 5 of the said order in mentioning the Effective Date of the order.

Now, vide this corrigendum letter, it is stated that the word/Digit "2008" shall be read as "2028" and thus, the Para 5 of the Order may be read as under –

"5. Above approval shall be effective from 02/07/2023 and shall remain effective till 01.07.2028 i.e. for the period of Five years to the terms and conditions specified in Notification No. 758(E) dated 7th Oct. 1992 remains satisfied. Failure to satisfy one or more conditions specified in the said Notification shall result in withdrawal of the approval so granted."
