Subject: Disposal of Old Condemned Vehicle:

1. Office of the Pr. Commissioner of Income Tax, Valsad is proposing to dispose of the following condemned vehicle on "**AS IS WHERE BASIS**".

2. Accordingly, sealed quotations are invited for the disposal of the above said vehicles on the terms and conditions mentioned below:-
- Persons/firms, interested in purchasing the above mentioned vehicle may submit their highest quotation in the enclosed Proforma in a sealed cover addressed to the O/o Pr. Commissioner of Income Tax, Valsad latest by **03:00 PM** on or before **13.11.2023** at Room No.301, 3<sup>rd</sup> Floor, Palak Arcade, Shanti Nagar, Tithal Road, Valsad - 396001
  - The bidders or their representative, not more than one for each quotation, may be present, if they so desire, at the time of opening of the quotations
  - The cover should be prominently superscripted with the word "**Quotation for purchase of Condemned Vehicle**".
  - The quotations received in time will be opened at 03:30 PM on the same day i.e. 13.11.2023 at the aforesaid office in the front of the bidders or their authorized representatives.
  - The vehicle will be available for inspection between 10:00 AM and 05:00 PM on any working day from 06.11.2023 to 10.11.2023, at O/o Pr. Commissioner of Income Tax, Valsad, Palak Arcade, Shanti Nagar, Tithal Road, Valsad

3. The Auction of said vehicle will be governed by the following conditions -
- a) The vehicles will be disposed of on "**as is where is basis**" and no guarantee for its worthiness of quality will be given by the O/o Pr Commissioner of Income Tax, Valsad.
  - b) The bidders are required to pay the Earnest Money of **Rs.2000/-** (Rupees Two thousand only) for vehicles as listed above.
  - c) The earnest money is payable by means of Demand Draft in favour of "**ZAO, CBDT, Surat Account**", payable at Surat. (Payment by cash or cheque shall not be accepted).
  - d) Quotations received without the demand draft towards the earnest money will not be considered and shall be rejected.
  - e) The Highest quotation for the condemned vehicles (cumulative of all vehicles) will be decided as selected bidder.
  - f) The successful bidder will be required to deposit the full bid amount by means of Demand Draft drawn in favour of "**ZAO, CBDT, Surat Account**", payable at Surat within two working days of acceptance of the bid.
  - g) The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again be taken up for re-auction.
  - h) The delivery of the auctioned vehicle will be arranged only after the successful bidder submits the documentary evidence in support of their residential status (Voter ID, AADHAR Card etc., in case of individual and Registration certificate etc., in case of firms or Company).
  - i) The selected bidder's address will be physically verified by the authorized representative of the O/o Principal Commissioner of Income Tax, Valsad before handing over the condemned vehicle.
  - j) Only the papers which are available with this office related to ownership of the condemned vehicle will be provided to the selected bidder. The disposal of vehicle is strictly not meant



- k) The condemned vehicle will be physically handed over to the selected bidder. The bidder will have to send the photos of before and after scrapping of the vehicle. Also the selected bidder will have to send the scrapping certificate of the vehicle to this office.
- l) The vehicle will be collected by the successful bidder at their own cost. If the delivery of vehicle is not taken within 5 days of completion of all formalities, the ground rent of Rs 500/- per vehicle per day will be charged. No assistance / transportation will be provided by O/o Pr. Commissioner of Income Tax, Valsad.
- m) Only those vendors which are registered as the Registered Vehicle Scrapping Facility (RVSF) under the guidelines of Ministry of Road Transport and National Highways can take part in the bidding. Bidders from all over India registered under RVSF are invited to take part in bidding. All such eligible bidders are required to attach their RVSF registrations details, credentials, etc.
- n) The O/o Pr. Commissioner of Income Tax, Valsad. Will not be held responsible in whatsoever capacity after the physical delivery of condemned vehicles to the selected bidder, if any untoward incident happens afterwards.
- o) Proforma for offering rate for disposal of condemned vehicles is available in 'Annexure-B'.
