Kind attention is invited to the advertisement for Young Professional Scheme in ITD-2023 vide F.No Pr.CC/ABD/HQ-Co-ord/YP-ITAT/2023-24 dated 11.08.2023, wherein applications were invited for engaging Young Professionals to aid the departmental officers in preparation of cases for hearing in the Hon'ble ITAT.

2. The applicants were required to submit their applications on or before 31.08.2023. The selection process is a two stage process, involving (i) screening and (ii) interview.

3. In this regard, the screening criteria of applications are as follows -

- i) Incomplete applications have been summarily rejected.
- j) Applications received after due date have been summarily rejected.
- k) Applications with the age of applicant as on date of advertisement, i.e. 15.08.2023, exceeding 35 years have been rejected.
- l) Applications in which essential educational qualification specified in the advertisement, i.e. (i) applicant should be an Indian national holding graduate /post graduate degree in law from a recognized university, college and institution of national and international repute, and/or Chartered Accountant, and (ii) applicant should have obtained at least 50% marks in the 3 Year LLB or 5 Year integrated LLB degree program or post graduation degree program or a qualified Chartered Accountant, are not fulfilled have been rejected.
