Subject: Proceedings under section 17(2) - Order

In exercise of the powers vesting with the undersigned under sub-clause(b) of Clause (ii) of the 1st proviso to Section 17 (2) of the I.T. Act, 1961 read with Rule 3A of the Income Tax Rules, 1962 approval is hereby granted to **M/s Swarn Jyoti Eye Hospital, A1/22, Sector B, Aliganj, Lucknow (PAN- AESFS5274G)**.

2. The approval accorded as above is only for the purpose of sub-clause (b) of Clause (ii) of the 1st proviso to Section 17 (2) of the I.T. Act, 1961 and should not be construed as approval of the Central Government or the Pr. Chief Commissioner of Income Tax, Lucknow or any other statutory authority under the Government, for any other purpose(s).

3. This approval is subject to withdrawal at any time, if it is found that the approval has been obtained through fraud and/or misrepresentation of facts, or necessary conditions as stipulated in sub-rule (1) of Rule 3A of the Income Tax Rules, 1962 are not fulfilled and is subject to modification/withdrawal, if necessitated by subsequent changes in the provisions governing the approval.

4. The approval is granted for the treatment of the following diseases and ailments-

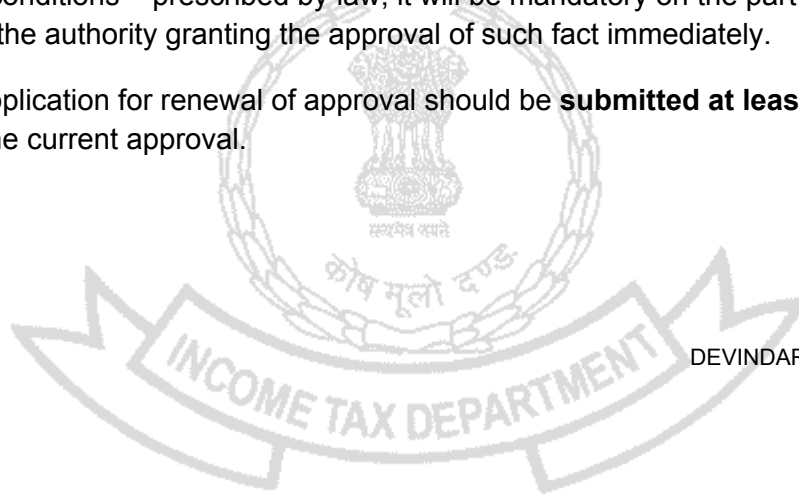
(i) **Ailment or disease of the eye requiring surgical operation.**

The approval shall take effect from 15.04.2024 and remain valid till 14.04.2027.

This order of the approval is subject to the following terms and conditions:-

- (a) This approval is not transferable.
- (b) The Hospital shall at all reasonable times be open for inspection by the authority of the Income Tax Department, duly authorized in this behalf.
- (c) The hospital shall conform to such conditions as are prescribed under sub-clause (b) of clause (ii) of the 1st proviso to Section 17 (2) of the I.T. Act, 1961, read with Rule 3A of the Income Tax Rules 1962. In the event that the hospital ceases to satisfy any of the conditions prescribed by law, it will be mandatory on the part of the hospital to inform the authority granting the approval of such fact immediately.
- (d) The application for renewal of approval should be **submitted at least 90 days** before the expiry of the current approval.
